A couple of bits to highlight this month:

1. The decision on HNRFI has been postponed to 10 March, in order for the applicant to provide additional information in respect of the main reasons the Examining Authority proposed consent is refused. The Secretary of State is minded to agree with the Examining Authority, but has given the applicant to the 10 December to respond, and then relevant parties can respond to those submissions no later than 31 January 2025.
2. The former recreation land on South Drive has now gone up for sale. We were officially informed of the decision in the same email sent to Stoney Stanton PC on 30/09.
3. Several properties around the district were flooded in the recent inclement weather. Both of us were in the council building and had to end a meeting early due to civic area starting to flood. Paul Coates and the team at the depot distributed sandbags to a number of locations, including Stoney Stanton, and we hope there has been no severe issues.
4. Statistics from the recent Residents' Survey shows 12 residents from Fosse Stoney Cove responded. We are keen to understand how we can improve participation in the survey.
5. We currently have no further updates on the impact of the NPPF changes to the Local Plan process
